President's Column

I wish to thank chapter officers and members of Pi Sigma Alpha who have taken the time to write to me in response to my proposal to raise admission requirements which appeared in the President's Column of the last PSA Newsletter. To date the response has been uniformly favorable and I intend to pursue the route of amending the national constitution. Meanwhile I hope that the officers and members of all local chapters understand that each chapter can proceed on its own to raise its requirements for admission.

In a recent letter to me, for example, a chapter secretary-treasurer complained that Pi Sigma Alpha "needs to be an organization that does indeed *honor* the students. And for this University, that only seems possible if the trouble is taken to amend the national constitution." Amending the national constitution may well help improve the national reputation of Pi Sigma Alpha as an honor society. Its reputation on any particular university campus, however, can be improved by the efforts of the local chapter members themselves. There is no need therefore to wait for the laborious process of amending the national constitution. I encourage all of you who agree with my proposal to start at the grass roots and persuade the members of your own local chapter to raise admission requirements. We at Georgetown have already begun the process.

APSA MEMBERSHIP AWARD

We wish to take this opportunity to remind our other chapters that the APSA Membership Matching Award of a \$15.00 membership in the national organization is an excellent way to reward students who excel in their work or duties while pursuing their academic studies. Each chapter is allowed to make these membership awards only once each year.

Chapters planning to take advantage of this offer should write to the national office indicating the two students who are to receive the awards, specifying which one will be paid for by the chapter and which one is to be financed by Pi Sigma Alpha national office. The names of the two persons to receive the awards should be announced in their school newspaper or newsletter and the chapter advisor must submit the names and notice to the national office. 1982 Chapter Proposal Award Winners

The Second Chapter Proposal Contest, which had a deadline of October 15, was very successful. Proposals came from 41 schools and were original and diversified. This made the job of the Selection Committee a difficult one. However, 16 awards were given of amounts ranging from \$100 to \$600. Some of the activity proposals of the winning projects were: forums with elected officials; student essay debates; lectures on political and social polling; providing sign language interpreters for deaf students; one-day conferences on political science and international relations; student panels at regional PSA conventions; symposium on censorship; program of careers in political science; film festival; issue awareness series; political action talks by young people and minorities; post election analyses; student convention with area schools; and presentation of research papers for awards. Chapter News

The tremendous response by UCLA faculty and students to their first publication of "Politicus" has resulted in many more articles and fund raisers for the

continuation of the journal. Students have been producing better quality work and seem to have more incentive to make better grades.

Gamma Gamma (Univ. of Connecticut) held a series of lectures designed to help students choose career objectives, goals, and direction. The chapter also prepared a Political Awareness Campaign to encourage students to be conscious of contemporary issues and exercise their vote in the November election.

Zeta Chi (Montclair State College, N.J.) held their fall initiation on December 6. The president spoke to the group on the ideals and value of being part of the honor society and emphasized the responsibility of continuing the tradition of excellence as a prerequisite to future inductees. Suggested Adviser Guidelines

A chapter operates effectively when the chapter adviser exhibits interest, enthusiasm, and initiative. The success of a Pi Sigma Alpha chapter depends upon the willingness of advisers who give of their time to carry on the traditions of the society. Duties of an adviser include:

- (1) Sees that the chapter elects members when they become eligible in order that they will have time to participate in Pi Sigma Alpha activities on campus. Members are welcomed by the national office at any time and in any number.
- (2) Sees that the chapter makes a public announcement of new members: in college, city, and hometown papers; on radio and television; on Honors Convocation programs.
- (3) Makes sure that there is continuity as student officers change.
- (4) If going on leave or retiring, makes sure that a replacement is appointed and that he/she has this set of guidelines.
- (5) Sends chapter news to the national office for use in Newsletter.
- (6) Helps make initiation ceremonies distinguished.
- (7) In general, supervises the chapter and encourages the student officers to assume the responsibility of conducting chapter affairs.

Chapter Member Qualifications

At every national meeting of chapter advisers the question of membership requirements is always raised by some participants. Local chapter advisers and officers are asked to send to the national office copies of their local membership criteria, especially those chapters who require higher qualifications than those established by the National Constitution. Your executive council is very interested in reactions or suggestions about changes in the national rules with respect to raising membership eligibility requirements. How do your chapter eligibility requirements compare with the following used by one of our member colleges?

UNDERGRADUATE STUDENTS:

1. Completion of at least 60 semester hours at the university with an overall grade point average of 3.4 or better
2. Completion of at least 15 semester hours in government and politics at the university with at least 6 semester hours at the "300" or above level and a grade point average of 3.5 in all government and politics courses.

GRADUATE STUDENTS:

1. Completion of at least twelve semester hours in government and politics at the university with at least 6 hours at the "800" level with a 3.5 GPA in government and politics with no grade being below a "B"
2. An overall GPA of 3.5 or better.

Chapter Activities

Typical chapter activities listed below may suggest opportunities available to PSA members to develop scholastic and other professional interests through local chapters.

1. *Regular closed meetings.*
Members present papers. Brief business session on chapter affairs.
2. *Open meetings.*
Addresses by nationally recognized speakers. Occasional reception of an honorary member, followed by an open meeting addressed by the new member.
3. *Social meetings.*
Dinners or luncheons upon reception of new members and in honor of visiting lecturers. Informal events as circumstances warrant. Picnics at appropriate times during the year.
4. *Reception of new members.*
New members are received into chapters at closed meetings with a short, dignified initiation ceremony. Open meetings and banquets may constitute part of reception activities.
5. *Publicity for chapter and departmental activities.*
Objectives of the society and developments in political science may be publicized through forums, news stories, campus newspaper, and other appropriate means.
6. *A chapter publication: bulletin board.*
Chapter newsletter containing local items, abstracts of research, chapter, and alumni news. Bulletin board as information outlet. Chapter room.
7. *Annual chapter picture.*
Framed and hung in political science department office. Included in the college annual.
8. *Contact with alumni.*
An up-to-date card file of alumni members. Occasional alumni letters. Use of alumni as news sources.
9. *Scholastic awards.*
High scholarship honored by an appropriate award, presented publicly on an appropriate occasion. Prize for the best paper in political science. Recognition may include cash award, PSA key, subscription to a professional journal such as *American Political Science Review* or *Public Administration Review*.
10. *Special events.*
Exhibits, inspection trips, co-operative projects with near-by chapters, addresses by chapter members before local civic groups, etc.
11. *Chapter finances.*
Sound financing through prompt payment of fees, regular treasury reports, and annual budgets.
12. *Presentation to political science department.*
Student aid funds, books, magazines, or "museum" apparatus for political science department.
